RULES, MAP & SCHEDULES

Rules & Regulations

- 1. Each team roster shall include only those players who have participated in league play for their organization during the current regular season.
- 2. Each teams composition will conform to the official tournament roster.
- 3. Any team not ready to play ten (10) minutes of their scheduled start time will forfeit the game. A team must have at least four (4) players to start the game, otherwise they forfeit.
- 4. Home teams will be the team listed at the top of each bracket. Visiting teams will be the team listed at the bottom of each bracket.
- 5. A tournament appointed scorekeeper and timekeeper will be designated as official scorekeeper and timekeeper for each game. Teams may have scorekeepers to keep their own records, but they may not interfere with the official scorekeepers.
- 6. All players cleared to participate in the tournament will be allowed to play regardless of protest from an opposing team. Protest of any player's eligibility can be made to the Sacramento Warlords Tournament Committee in writing after the tournament. Findings may have future consequences for any player and team found to have been in violation.
- 7. Protest of any game must be made to the Sacramento Warlords Tournament Committee of the respective divisions within five (5) minutes after the conclusion of the game in question. This committee has the authority to act and its ruling is to be accepted by the teams involved. All teams shall be responsible for the enforcement of the Rules and Regulations.
- 8. The Sacramento Warlords Tournament Committee has the power to act if any infraction occurs and its ruling is to be accepted by the team or teams involved. This includes post game forfeiture of games at any time.
- 9. The medical expenses of a player(s) injured during this tournament play will be the responsibility of the team they represent. Each team is expected to have insurance so that player(s) will be adequately covered.
- 10. Sacramento Warlords, its affiliated organizations, its officials and its member and tournament officials and coaches, the Sacramento City Unified School District, the Elk Grove Unifed School District, Sacramento Asian Sports Foundation, and all other activity sites shall not be responsible for any injuries to players and/or the spectators, or for the loss of players or spectators personal property.

Eligibility of Players

- 1. Players must be division grade or below.
- 2. Players cannot play for more than one (1) team and one (1) division. Failure to comply will lead to player disqualification from the tournament and team forfeiture of the game.
- 3. All rosters and waivers will be reviewed by the Sacramento Warlords Tournament Committee. This committee reserves the right to accept or deny any player.
- 4. The medical and liability release agreement form MUST BE SIGNED by the parent or legal guardian of each player and submitted before players will be allowed to participate in any tournament activity.

Game Rules

- 1. All games (including girls games) will be played under Boys Basketball Rules Book of the National Federation of State High School Associations (NFHS), current edition, with the exceptions stated in subsequent paragraphs.
- 2. All players of each team must have same colored uniforms.
- 3. Any single or double-digit uniform number is legal.
- 4. No shot clock shall be used in any division.
- 5. No three (3) point goals in gymnasiums where there is no three-point line on the court.
- 6. Game Format

(a) Game time

Eight (8) minutes per quarter stop time, with one (1) minute between quarters and five (5) minutes between halves.

(b) Timeouts

Each team is permitted two (2) 30-second timeouts and three (3) one-minute timeouts per game.

(c) Overtime - Championship

In the event of a tie, there will be an additional three (3) minute stop time period. If the score is still tied after an overtime period, then another overtime period will be played. Only one timeout permitted per overtime. Unused timeouts may not be carried over from regulation or previous overtimes into an overtime period.

(d) Overtime - All other games

In the event of a tie, there will be an additional three (3) minute running time period, with stop time in the final minute. If the score is still tied after the overtime period, the game will go into sudden death, with the first team to score declared the winner. Only one timeout permitted in overtime. Unused timeouts may not be carried over from regulation into an overtime period.

(d) Mercy Rule

If any team is leading by a score of 20 or more points in the last two (2) minutes of the fourth quarter, the remainder of the game will be played on running time.

- 7. Determining the standing for a six (6) team division. The standings for a single three (3) team pool will be determined by:
 - (a) i. BEST WON/LOST RECORD
 - ii. A three (3) team tie will be broken by quarters won in the first two (2) games
 - iii. Head to head between the two (2) tied teams will determine who plays for third place and consolation.
 - (b) If all three (3) teams are tied in won/lost record AND total quarters won:
 - i. Coin flip: Three (3) team coin flip, odd coin out goes to championship.
 - ii. Head to head between the two (2) tied teams will determine who plays for third place and consolation.

UNSPORTSMANLIKE CONDUCT WILL NOT BE TOLERATED

Ref. of the Coaches Code of Ethics National Federation Coaches Association:

"The coach shall be aware that he or she has tremendous influence for either good or ill, on the student athlete and thus, shall never place the value of winning above the value of instilling the highest ideals of character."

8. Technical Fouls

- (a) When any technical foul is called, the opposing team will automatically be awarded two (2) points and will receive possession of the ball.
- (b) Direct Coach Technicals
 First technical results in loss of coaching box. Second direct coach technical results in ejection of the coach from the game. The coach must leave the gym and remain 100 feet from the premises.
- (c) Player Technicals

A technical foul resulting from player trash talking (to an opposing player, coach, spectator or referee) will also disqualify the player for the remainder of the quarter in which the technical was committed, with a minimum of four (4) minutes on the bench. Any remaining time will be carried over to the next quarter of that game.

(d) A second technical results in ejection of from the game. The ejected player or coach must leave the gym and remain 100 feet from the premises.

9. Fighting

- (a) Fighting will result in automatic ejection and ban from further play and attendance of all tournament activities.
- (b) A player or coach who is disqualified from a game for fighting must leave the premises and remain 100 feet from the gym.
- (c) The game will not continue until the disqualified player or coach leaves the premises and remain 100 feet from the gym. A three (3) minute delay due to the failure of the disqualified person(s) to leave will result in forfeiture of the game.
- (d) Compliance will be a team responsibility. Failure to comply will result in forfeiture of the game and exclusion from future tournament participation.

10. Flagrant Fouls

A flagrant foul resulting from a player to the opposite team will result in shooting at the free throw line for two (2) points and possession of the ball.

CONCUSSIONS

As stated in the NFHS rules:

"Any athlete who exhibits signs, symptoms, or behaviors consistent with a concussion (such as loss of consciousness, headache, dizziness, confusion, or balance problems) shall be immediately removed from the contest and shall not return to play until cleared by an appropriate health care professional."
